1 DELEGATE KILGORE: Good morning.  
2 We don't have a quorum as of yet, so I'm going to turn it over  
3 to you Evan and tell us about the CAER building, that deal.  
4 We've got three members on the way and we'll get there but  
5 let's go ahead until we get all the members here.

6 MR. FEINMAN: Thank you, Mr.  
7 Chairman and I'll remind everybody this currently is not a  
8 deal yet because we don't have a quorum, more of an  
9 informational visit and we'll wait until all our members arrive  
10 to get this done.

11 I think you know that the Commission  
12 has funded CAER in a number of different ways for many  
13 years and there's been some issues with their long term goals  
14 or long term sustained goals.

15 They received a proposal from Liberty  
16 University where Liberty would take over the facility and then  
17 make it a centerpiece of an energy focus engineering campus.  
18 That's only about ten or twelve miles down the road from  
19 Liberty's main campus. It was attractive to them as they  
20 acquired a remote campus. The initial proposal was for  
21 Liberty to purchase the building at the appraised value, which  
22 is \$4.37 million and then use the proceeds from that purchase  
23 to build themselves a second building right next to it as a  
24 beginning of their buildout of the campus. I expressed some  
25 concerns about the proposal given the fact that we have

1 funded it with taxpayer dollars and the building and all  
2 proceeds from the sale would leave the public coffers.

3 The Commission asked me to meet with  
4 them and come up with a solution that honored our concerns  
5 but still got this deal rolling and I think I've done that. We  
6 had a couple of very cordial negotiations and not a lot of  
7 contention.

8 Where we landed is that essentially  
9 Liberty will purchase just the building and not the control  
10 room or the actual cullin loop which is the much more  
11 valuable piece of the structure. They'll purchase the building  
12 at the building appraised value of \$4,338,500. We will take  
13 half of that money and CAER will take half of that money.  
14 Our half we said we will earmark for Bedford County in the  
15 Southside Economic Development Committee's allocation for  
16 them. That with respect to the fact that there's a couple of  
17 businesses in there right now and Bedford would get about  
18 \$150,000 a year in property taxes from this facility, which  
19 they won't get once it's owned by a non-profit university at  
20 Liberty. Other than that, we can do what we will with the  
21 money.

22 CAER will take their half and they're  
23 going to pay all of the transactional fees out of their portion of  
24 the money. They're going to work with Liberty on that \$1.7  
25 million worth of build out for Liberty's new campus and they

1 will collaborate with Liberty for purposes of setting up a new  
2 energy cluster which will be in keeping with CAER's nonprofit  
3 building mission. That would be more with their portion of it.

4 Now, the long and short of it, I think this  
5 is a pretty good deal. We take some of our claw back back  
6 and we allocate some of it to the project really reflective of the  
7 fact that Liberty is taking on an asset that's in the red we  
8 funded and injecting some new capital into it in the form of  
9 millions and millions of dollars, as many as nine million  
10 dollars and Jonathan can speak to the specifics of that. So, in  
11 reaching an accommodation I think this will work well for all  
12 the parties. So I'll be happy to take up some questions and  
13 I'm sure the other parties will, too.

14 DELEGATE KILGORE: I think everyone  
15 has the revised proposal that Evan worked on and I appreciate  
16 Evan the work you've done on this because the rest of us were  
17 busy during the session. So I think you've accomplished what  
18 we've asked you to do. He is correct because this appears to  
19 be in the red and it appears to be a possibility that  
20 Commission funds could be at risk anyway. So I think this  
21 proposal is a win-win for everyone. Does anyone have any  
22 questions?

23 DELEGATE MARSHALL: Since we don't  
24 have a quorum?

25 DELEGATE KILGORE: As soon as the

1 door opens, we'll have a quorum.

2 DELEGATE MARSHALL: Can someone  
3 from CAER tell us about what's going to happen or anything  
4 new since our last meeting?

5 MR. BAILEY: I'm Bob Bailey, executive  
6 director for the Center of Advanced Engineering and Research.  
7 And we also have representatives from Liberty University and  
8 Bedford County if you have questions relative to their role in  
9 this project.

10 Evan is exactly right. We sat down and  
11 worked out a proposal that would provide the funding back to  
12 the Commission and then would be put into Bedford County's  
13 allocation. We've been talking with the county about the  
14 building in the park, so that's another aspect of this proposal  
15 that would do what you had before plus a significant research  
16 campus. CAER has been very supportive of this because our  
17 vision in the beginning was to create a research university  
18 environment and we think this is a big step in that direction to  
19 make that happen.

20 Are there any specific questions that  
21 you'd like to address?

22 DELEGATE MARSHALL: Let's talk about  
23 the curriculum that they will have at this location.

24 MR. WHITT: I'm Jonathan Whitt, vice  
25 president of special projects at Liberty University. To answer

1 your question, we really view this project as an exciting  
2 opportunity. We can build on the initial investment with  
3 CAER and on that property for energy research and we want  
4 to focus on that property. Liberty University School of  
5 Engineering will be moving to that campus and working with  
6 the private sector to scale up our engineering programs. One  
7 of the things we've been saying for a while is that we view this  
8 also that this will give us increased job opportunities and a lot  
9 of promise for CAER job development. As you know in the  
10 Commonwealth and as a university, we love to really double  
11 down academically supporting that energy sector.

12 MR. BAILEY: As part of my role, I sit on  
13 the advisory board for the engineering school and specifically  
14 part of the plan will include the addition of two undergraduate  
15 degrees, at least one new Master's and maybe two Master's  
16 degrees and as part of a research university building towards  
17 a Ph.D. We know that the Ph.D. would have some kind of  
18 energy focus and that hasn't been defined yet exactly what  
19 that would be. But that would include two new  
20 undergraduate degrees, at least one new Master's and  
21 possibly two Master's degrees and a Ph.D. available.

22 DELEGATE KILGORE: Does anyone else  
23 have any questions?

24 MS. CARTER: I have a question so I can  
25 understand the process here moving forward. When this deal

1 is done, half will go to the center CAER and half would go to  
2 Liberty University?

3 MR. BAILEY: No, half will come back to  
4 the Commission and allocated to Bedford County under their  
5 Southside Economic Development allocation.

6 MS. CARTER: Now this is my question  
7 here, Liberty is going to take the money that comes to CAER  
8 and do certain things with that money?

9 MR. BAILEY: Yes, CAER will collaborate  
10 with Liberty University for build out on the campus because  
11 that's part of this whole thing.

12 MS. CARTER: Then will Liberty at that  
13 time own the building?

14 MR. BAILEY: Yes.

15 MS. CARTER: So part of it goes to CAER  
16 and part to Liberty?

17 MR. BAILEY: Yes, that's part of the  
18 collaborative process that we have undertaken and a partner  
19 in building out that campus and building out the programs.

20 MS. CARTER: What kind of collaboration  
21 will there be with this body once that's done, any?

22 MR. FEINMAN: Obviously, I don't want  
23 to speak for Liberty but I'm sure they'll be happy to work with  
24 us moving forward with anything we can partner on. We  
25 moved in a controlled, we take this claw back, our property

1 interest in the building.

2 MR. BAILEY: With the exception, there is  
3 three grants that are related.

4 MR. FEINMAN: Yes, I should have said  
5 that. We punted a little bit on that matter and we'll figure that  
6 out over the coming years. We continue to have a property  
7 interest in controlling the rights of any transfer of the control  
8 room equipment and we're going to figure that out over the  
9 coming year. There wasn't a time crunch on that and that  
10 was complicated and we decided not to reach it here.

11 DELEGATE KILGORE: Anyone have any  
12 more questions?

13 DELEGATE BYRON: Mr. Chairman, I  
14 just wanted to say thank you to the staff and to Evan in  
15 particular for the time and effort you put into reaching this  
16 amicable agreement. I think we do have a great opportunity  
17 here to do something that we'll all be very proud of in the  
18 future. So thank you.

19 DELEGATE KILGORE: All right, thank  
20 you. Does anyone else have any questions? We now have a  
21 quorum, so we can get started.

16 and a second to approve the minutes. All those in favor say  
17 aye. (Ayes.) Opposed? (No response.) The minutes are  
18 approved. On the CAER proposal, do you need any further  
19 discussion? All right, I've got a motion to approve the  
20 proposal of the CAER. Any more discussion or any more  
21 comment? All those in favor say aye. (Ayes.) Opposed? (No  
22 response.) All right, that motion carries. Thank you and  
23 thank you Evan and the staff for your hard work on this  
24 project.

25 Now we're going to go to the Massey

1 Bridge Funding Request. Tim?

2 MR. PFOHL: Thank you, Mr. Chairman.  
3 Yesterday the Commission received a new funding request for  
4 a project funded under the healthcare objective and metrics  
5 under the Special Projects program. It is a thorough and  
6 detailed request from the Massey Cancer Center VCU to  
7 continue funding for the two cancer research and resource  
8 centers in southern Virginia. One is in Danville and one in  
9 Lawrenceville. This is an out of cycle request so this has not  
10 gone through the Committee review process, the Special  
11 Projects program currently has an available balance of \$6  
12 million. The game plan is to announce a cycle this summer  
13 for September funding decision. Consideration of this request  
14 would come out of that balance and then would be available in  
15 the next cycle. We've provided the executive summary from  
16 the applicant and the outcome metrics, the line item detail  
17 operating budget and the milestones and deliverables for the  
18 request. Again, this is continuation funding for the two  
19 centers that the Commission has been funding for a number  
20 of years out of the Special Projects program, so it's nothing  
21 really new and this is very well known to us and this involves  
22 two centers. With that, I'll let Delegate Marshall address it.

23 DELEGATE KILGORE: All right, Delegate  
24 Marshall, Special Projects.

25 DELEGATE MARSHALL: Thank you, Mr.



1 Chairman. I'll ask the two representatives from Massey to  
2 come forward please and maybe you can give us a little  
3 update. We have some new members here who have not  
4 heard about what you do. Briefly tell us what you do in  
5 Lawrenceville and in Danville.

6 DR. HOULIHAN: I'm Dr. Houlihan  
7 representing Virginia Commonwealth University Massey  
8 Cancer Center. We're here this morning to request some  
9 bridge funding because the current grant was awarded last  
10 year and it expired September 30<sup>th</sup>, 2016.

11 Since that time, Massey has recognized  
12 the importance of continuing these projects and activities that  
13 are currently carried on down in the Lawrenceville area and in  
14 the Danville area. The cancer resource and research centers  
15 have been funded by the Commission for a number of years  
16 indicated by Mr. Pfohl.

17 To give members of the Commission and  
18 especially new members a little perspective on the activities  
19 that are going on and the results that we have achieved down  
20 there. Since the inception, we have actually served over  
21 37,000 residents of the region. This includes cancer  
22 prevention, control, education, seminars, conferences,  
23 regional activities as well as most recently provider education.  
24 We're taking this opportunity to work with those providers  
25 that provide experience serving the communities in the region.

1 That includes the importance of cancer prevention as well as  
2 those individuals that have been diagnosed with cancer to give  
3 them an opportunity to live a healthy life.

4 We have recently embarked upon several  
5 collaborative endeavors to include activities with the tax  
6 organization in the area of AHAB for the state as well as a  
7 number of educational institutions. We have partnered with  
8 the hospitals in Danville, Martinsville, Farmville, Emporia,  
9 South Hill and South Boston. We have actually brought those  
10 leaders to the table together to work out programs in order to  
11 serve those residents down there.

12 It's important while the members of the  
13 Commission might not necessarily have an opportunity to visit  
14 the various centers, the two centers, we do encourage you to  
15 please come to one of them and take a look and talk to the  
16 residents in the communities. We have received letters and  
17 faxes from those individuals that we've been able to help.

18 We also provide funding opportunities for  
19 travel for individuals that have been diagnosed down there  
20 that need to come to Massey for a second opinion or for  
21 detailed treatment options. We have opened a number of  
22 clinical trials down in the area, especially out of hospitals  
23 where patients actually have an opportunity to participate in  
24 innovative clinical trials and treatment options that have  
25 absolutely benefited them.

1                   We have also performed in almost 600  
2 community events and we use a number of different venues in  
3 locations and partner with virtually everyone in the Southside  
4 region. Recently, members of the legislature had an  
5 opportunity to get some information from the cancer center  
6 and thank them for their continued support. I want to let you  
7 know as well not only do we partner with the hospital systems  
8 and other entities such as the American Cancer Society and  
9 the Coleman Foundation.

10                   We also work with nine school systems,  
11 eleven religious organizations, 37 local businesses in the area  
12 and they have partnered with us because they recognize a  
13 healthy workforce is a productive workforce and that's really  
14 the purpose of the cancer research centers are for.

15                   DELEGATE MARSHALL: If you will  
16 briefly tell us about the cancer rates in Southside Virginia.

17                   DR. HOULIHAN: The cancer rates  
18 continue to be the worst in the state of Virginia. The  
19 Southside region or actually the health outcome lags behind  
20 the areas of Appalachia. We recognize there's a tremendous  
21 need and we are working diligently and more importantly and  
22 recently the areas in Brunswick County with the Lawrenceville  
23 center serve have been recognized as one of the three hotspots  
24 in the nation for colon and rectal cancer. We actually  
25 implemented and putting together programs to not only for

1 education but screening, diagnosis and treatment for  
2 individuals that have actually received this disease.

3 DELEGATE MARSHALL: With your help  
4 because a lot of those cancers could be preventable, correct?

5 DR. HOULIHAN: Correct. We found that  
6 the healthy lifestyle living is one of the basic preventive  
7 measures as well as seeing physicians for their primary care.  
8 Early diagnosis usually an indication of a better outcome for  
9 those individuals that have been diagnosed.

10 DELEGATE KILGORE: I know you all  
11 have been doing a great job. Does anyone else have any  
12 questions?

13 MR. OWENS: When did we give this  
14 allocation, Mr. Chairman? I know they do good work but is it  
15 fair to other potential applicants for Special Projects money to  
16 just let them step in right now and do this application?

17 DELEGATE KILGORE: I think it's  
18 something we have committed to funding and I think that's  
19 the reason that the Chairman of the Special Projects, it's  
20 something we've done in the past and committed to in the  
21 past.

22 DELEGATE MARSHALL: It's not a new  
23 project. We've funded it many times, is that right Tim?

24 MR. PFOHL: There's a total of five grants  
25 to Massey, not all of which involve funding for these centers

1 but the two most recent grants I believe are the ones that are  
2 primarily concentrated for funding of the centers.

3 DELEGATE MARSHALL: The cycle for  
4 healthcare for Special Projects, we did want to have a pause  
5 for what they were doing. You've heard that 37,000 people in  
6 our region have been served by them.

7 MR. OWENS: Will this project meet the  
8 standard or the plan to provide these services?

9 DELEGATE MARSHALL: Hopefully they'll  
10 cure cancer.

11 DR. HOULIHAN: I can answer that. The  
12 plan is actually set up to be sustainable. We're working with  
13 the research committee at VCU as well as Hampton  
14 University. We anticipate submitting what is called a planning  
15 grant integration program at Hampton University who has a  
16 history of community engagement research as well as VCU  
17 who has the patient side research address the Southside  
18 region. Recently in working with the Center for Health  
19 Innovation as well as the Virginia Foundation for Health  
20 submitting joint applications where they would focus on their  
21 missions and we'd actually be able to partner with them in  
22 order to provide funding for our work that we've been working  
23 on. We have a large grant proposal that we are preparing to  
24 submit for HPV related cancers.

25 DELEGATE MARSHALL: That's a match.

1 MR. OWENS: Are we going to match this  
2 with another or review it?

3 DELEGATE MARSHALL: Special Projects  
4 in the fall will have a healthcare related round of funding.  
5 This right here bridges them to that time in September. That's  
6 why this is the bridge.

7 DELEGATE KILGORE: This is the bridge  
8 funding.

9 MR. OWENS: What's our total  
10 investment to date?

11 MR. PFOHL: \$5.3 million in five grants.

12 MS. CARTER: I have a question. I see  
13 there's some staff and salaries here.

14 DR. HOULIHAN: They are residents of  
15 Southside. I do want to make one additional proffer about  
16 funding. Since the inception, Massey has matched \$9 million  
17 so we are actually multiplying in order to build a foundation  
18 and we're now poised to have additional funding in order to  
19 launch the next phase.

20 MR. OWENS: Is that \$9 million been  
21 spent in our footprint?

22 DR. HOULIHAN: Yes.

23 DELEGATE BYRON: Certainly the  
24 subject matter is not something anyone wishes on anyone to  
25 have to deal with cancer. I would just add that maybe when

1 Special Projects before the fall, maybe we could get or bring  
2 some of the residents of the footprint in to share some of their  
3 stories or to actually hear from some of them.

4 DELEGATE MARSHALL: What Senator  
5 Ruff and I have proposed to do is visit the Danville location  
6 and we can get some other people to help. When you consider  
7 37,000 residents, Doctor, maybe you can send to our staff and  
8 they can send it to the full Commission; you gave a report a  
9 couple of years ago about the amount of what cancer was  
10 doing in our area and you mentioned that we were one of the  
11 hot spots. It's one thing to have jobs but if you don't get a  
12 healthy employees to work there, you're fighting a losing  
13 battle.

14 MR. HARRIS: Mr. Chairman, I'd rather  
15 have quarterly.

16 MS. GOULD: When did we, we set the  
17 schedule or the term ends or healthcare, was it in the fall?

18 MR. FEINMAN: Every Committee meets  
19 at the call of the Chairman. What we do with each Committee  
20 Chairman, we try to get a gauge on the landscape of the  
21 requests that are out there and if it's going to be a little thin,  
22 we push it back. My concern with the grant round, fund them  
23 all regardless. We've been working with Delegate Marshall.  
24 We pulled back a little bit. That has delayed some of these  
25 things.

1 MS. GOULD: When was that decision  
2 made to push back Special Projects from the spring to fall?

3 MR. PFOHL: Over the last couple of  
4 months.

5 MS. GOULD: I guess the question is if  
6 the applicant was made aware of this two months ago, why are  
7 we getting a proposal two days before a specially called  
8 meeting?

9 DELEGATE MARSHALL: They didn't  
10 know that we were pushing back. They respond to what we  
11 put out.

12 DELEGATE KILGORE: Any other  
13 questions?

14 MS. BARTS: If these funds are not made  
15 available, what will happen with these physicians?

16 MR. FEINMAN: The grant applications  
17 and without this as their baseline, will maybe able to serve  
18 302 patients over this period with the funding, I would think  
19 there's going to be a difference.

20 DR. HOULIHAN: Some of the activities  
21 we will continue because of a relationship with healthcare  
22 facilities in Southside and hospitals at VCU. We would have  
23 some clinical trials but we would not have other activities.  
24 We'd have to scale them back substantially.

25 DELEGATE KILGORE: Are there any



1 other questions? Do I have a motion?

2 MR. SHELL: I'd have to abstain.

3 DELEGATE KILGORE: Do I have a  
4 motion to approve this? Do I have a second? All those in  
5 favor say aye. (Ayes.) Opposed? (Nos.) We have three nos
